## Rubbish

Please place all rubbish in a bag, and tie it before tossing in the trash chute or placing it in the dumpster. Disposing of rubbish in a tied bag reduces items getting caught in the trash chute, helps control pests, and helps prevent rubbish blowing out of the dumpsters when they are emptied.

Nothing should be left on the floor of the trash chute rooms or next to the dumpsters. Cardboard boxes or any other items that may clog the trash chute must be taken to the dumpsters in the ground floor trash area.

Please note, trash chute hours are 8:00am to 9:00pm and should be used only during those hours. (House Rules, page 19)

## Removal of old appliances, furniture, and other bulky items

Residents are responsible for contacting the City and County of Honolulu to make arrangements for the removal of their old appliances or pieces of furniture (808-768-3200). An immediate fine of \$250.00 may be imposed for each occurrence of bulky items that are left outside when no collection is scheduled (in addition to the costs that the City and County may charge for the removal of bulky items). ## Noise and Quiet Hours

Living in a condominium means, in part, being considerate of your neighbors. Noise travels in a complex such as Plaza Hawaii Kai. Residents and Guests are expected to be aware of noise that may disturb, or annoy other members of the PHK community. This applies at all times, but especially during the hours between 10:00pm and 8:00am (between 11:00pm and 8:00am Friday and Saturday nights and the night before a holiday) which are the official quiet hours. Residents should avoid the use of noisy appliances, musical instruments, and other household equipment, etc. that could disturb other Residents and Guests.
